### Basic skinless pork sausage recipe for reference

- 500g ground or minced pork
- ½ cup fresh breadcrumbs
- 1 large spring onion finely chopped
- 1 beaten egg

- 1 tsp dried sage
- ¾ tsp salt
- ½ tsp black pepper
- Flavour, ingredients and quantities based on 500g of meat.

### **Privacy Notice – Belper 250**

Members of Belper 250 (“we”) value the trust you put in us to process your personal information. We will always be open and honest about the information we collect and how we will use it. We will never do anything with your personal information that you wouldn’t reasonably expect us to in relation to this Competition and Exhibition. We will always make every effort to protect your privacy.

### **How we use your personal information for Youth Competitions**

We are collecting your personal information solely for the organisation and administration of this competition/exhibition. It will not be used for any other purpose.

Event organisers from Belper 250 may use your personal information to contact you to discuss public relations opportunities. They will gain your specific consent at that time for the use of your information (such as photographs or interviews for newspaper articles, websites, etc.).

### **Providing your personal information to others**

Personal information will only be shared with others who require it for their role or for the services they provide regarding the organisation and administration of the event.

It may be necessary to share some of your information with third parties, such as competition judges.

All individuals and organisations that have access to your personal information are also bound by the Belper 250 Privacy Notice.

### **Retaining and deleting your personal information**

All reasonable steps will be taken by those concerned to ensure the personal information they have access to is kept securely. It will not be shared with anyone who does not have a legitimate reason to access it in relation to the organisation and administration of this competition/exhibition.

For the Strutty Banger competition, personal information will be kept on file for 3 months after the date of the event. After this date, the information will be securely destroyed (either by shredding, incineration, or deletion from electronic devices). This timeframe is necessary to allow for any disputes to be settled before the personal information is destroyed.
